Executive

Place

Philip announced that an adjusted contract as presented, to repair and upgrade portable onsite at 1330 Fairfield Rd could be started in August and completed by mid-October. Contract presented is with Aryze Developments and is a fixed rate contract for maximum scope of the project. **Moved** by Philip, second by Forrest that the contract be approved and awarded as presented. **Carried. Moved** by Philip, seconded by Forrest that the expenditure of \$90K be taken 50% from operational reserves of 2016-17 budget and 50% from cash reserves. **Carried.**

Finance

Philip outlined an investment plan for GIC's going forward 2-3 years

CALUC

David circulated the Dallas Rd. amenities report. Suggestion that immediate neighbors be invited to preliminary developer presentations. There are now four Board members on the CALUC.

Motion by David Biltek, seconded by ??:

I move on behalf of the Committee that we advise the Mayor and Council plus the Mayor's Task Force on Daycare that they should consider:

Daycare, high quality daycare is a general benefit for the whole city, society, and making sure it is adequately provided and located would be a worthwhile public policy for City Council, therefore

it behooves the City to develop a policy on location of day cares and

to scale day cares into small, and large and designate appropriate locations for both. Perhaps small day cares located in residences with ten or fewer children are appropriate for residential neighbourhoods, while larger day cares which do have a place in the service spectrum should be located in more highly developed areas. Perhaps a policy for major commercial and/or residential developments whereby day care facilities are required within the premises would be a worthwhile

Fund Development/Community Engagement

Discussion of "rewards cards" for FGCA members at local businesses.

Street Life

Heather will have meeting July 20th and issues would include: Emergency preparedness, urban forest, renaming Trutch St.

VCAN

Strategic Planning

Forrest outlined Governance Strategic Priority. Purposes are to be drafted for September board meeting, bylaws for November.

Motion to accept all committee reports: Philip Sawkins/2nd Brett Duncan, **carried**.

Old Business

Alice circulated report on Moss St Farmer's Market. Report was seen as valuable knowledge, questions around the market moving? Parking, uncertainty causing issues, many feel the market is the best thing in Fairfield. Perhaps needs total rethink!

New Business

AGM date set for Oct.21, 2-4pm.

Motion by David Biltek, seconded by Paul Brown:

That the Board of the FGCA appoint a Task Force on Bicycle Lanes in Fairfield and Gonzales. The task is primarily but not restricted to:

- reviewing the proposed bike lanes that the City of Victoria has for these neighbourhoods,
- looking at alternatives,
- assessing casual routes already in use by cyclists and if there is some way to enhance and designate,
- assess suitability of bike maintenance centres in various locations in the neighbourhoods.

The task force is also requested to review these initial terms of reference and advise on additional items after their first two meetings

The task force would use surveys, community meetings, direct meetings with cyclists and city officials and other means to make their assessments.

The task force would commence work by September 1st, and would be expected to report back by January 15th, 2018.

The task force would be composed of 10 - 12 people from the neighbourhoods who have an interest in cycling, public policy, parks and recreation, public transportation, and will commit the necessary time to complete the task on time, one of whom will be appointed by the Cook

Street Village Association, as well the Board may choose to appoint one of their number to the Task Force

The outcome would be a report to the Board with recommendations as to future actions, policy decisions, or representations etc. that the Board and the FGCA might take.

The task force could be appointed and supervised through the CALUC or report directly to the Board

The Chair will be appointed by the Board on the recommendation of the Task Force

Notices in FGCA emails, the Observer (if available), Facebook Posts and referrals from Board and staff would be used to recruit members

Motion carried.

Reconciliation activities. **Moved** by David Biltek, seconded by Heather Murphy that the Board advise Mayor Helps that the FGCA would like to take on a reconciliation project or projects in the neighbourhood, and that we would like her to bring this to 'The Family'. Motion **carried**, AW abstained.
